



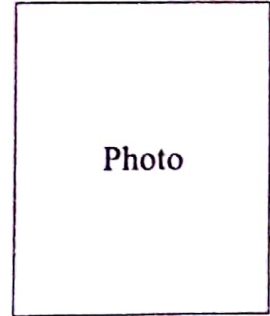

# DECLARATION

  4. Absence from classes and hostel for more than seven days without prior permission.
  5. Irregularity in attendance, in payment of college and hostel dues and in any other related matters.
  6. Misuse or destruction of college and hostel properties.
  7. Provoking students to take part in strike, Mochas or formation of Union / Association, the objective of which is directly or indirectly political or communal.
  8. Arranging meetings or inviting some person/persons to address any meeting in the College/ Hostel premises without prior permission of the College Management.
  9. Use of Drugs/ Alcohol in the College/Hostel/City.
  10. Involvement or conduct of the acts against court of law.
  11. Involvement in a mass absent from classes.
5. I also understand that if I am found involved in an act of Indiscipline, I am liable to any one or more of the following punishments.
  1. Warning to me and my Father / Guardian by the College Management.
  2. Marks fine or Monetary fine or both.
  3. Reduction/ Cancellation of Scholarship/ Stipend/Fellowship.
  4. Recovery in parts or full of losses or damages to College / Hostel property or property of others.
  5. Suspension from availing of any of College amenities and services or from classes.
  6. Remove / Rustication or Expulsion from the College and / or Hostel.
  7. Withholding of Character Certificate.

  - (a) I have not been convicted of any criminal offence nor have been released on bail in connection with a criminal case.
  - (b) No case of criminal offence or moral turpitude is pending against me in any court of law.
  - (c) No complaint or F.I.R. has been lodged against me by the University / Principal of a constituent College / Affiliated College or by any other, competent authority.
